CALL TO ORDER:

Mayor Karl Curtis called the meeting to order at 7:00pm.

APPROVAL OF AGENDA:

PRESENTATIONS:

a. Safer Neighbourhoods and Communities (SCAN)

Steve Gourdeau and Jeff LaFrance talked about how their group and the RCMP can work together to eliminate criminal activities in New Brunswick communities.

b. Andrew Cougle, Fire Chief

The department attended 1 chimney fires, 3 motor vehicle accidents, 1 ambulance assist, 1 alarm call and 1 structure fire since the last meeting. Bi-weekly training continues. The departments new slope rescue kit has been ordered which will enhance our slope rescue abilities as they connect very quickly saving time. Yearly pump tests are completed and two passed and the other needs some repairs. April 23 and 24 the department is hosting a pump operator course for local fire departments. The department worked on the tender for the new pumper truck. A department Captain is taking PTSD training in Fredericton and will be part of the provincial team as well. All firefighters have been invited to a blue mass for first responders at St Leo's Church on May 5.

c. Camp Shiktehawk

Richard Woollin presented the Camp's proposal to offer a unique winter experience for the local community called Cabin Fever 2020 which will occur most weekends in February and March offering a range of indoor and outdoor activities.

d. Florenceville Kinsmen

Jody Foster gave a summary of what their club has accomplished during the past year. They are currently 18 members with 3 new members joining this year. Fundraising activities include cotton candy and popcorn sales, Spring Craft Fair, the Cystic Fibrosis (CF) walk in Bath, catering and hall rentals, Canada Day chicken dinner and other Town events catering, Toy Run canteen and bracelets at gate, benefit breakfasts, Christmas Miracle, Fall Craft Fair, and grocery card draws. Thet have donated to CF, offer their hall for free to 4H and other groups, host an annual seniors' dinner, donate to youth sport and music programs and various acts of kindness (such as a sliding party in Town). The Kinsmen had their 45th anniversary of the club. The Kinsmen are planning an event for National French Fry Day to raise money for CF. Jody asked Council to let them know if there is anything they can do for the Town.
